1. Call to order 6:35 p.m.

2. Welcome and introductions – Christy welcomed everyone to the meeting with round table introductions.

Land Acknowledgement: We acknowledge with respect the history and culture of the First peoples with whom Treaty 6 was signed and the land upon which Glen Allan School resides. We also acknowledge the traditional homeland of the Métis Nation. We recognize our responsibility as Treaty members and honor the heritage and gifts of the First Peoples. 4. Approval of May 19, 2021 Minutes (Attachment I)

5. EIPS Trustee Report – Don Irwin

"I hope all parents and staff had a restful summer and we are looking forward to the next school year and returning to near normal.

The board has been busy in August with school start up discussions and then bringing revisions later in August and early September as the fourth wave of Covid has affected schools and the community.

We felt it wise to institute a full masking program on an interim basis until the number of cases

turns around. This decision will be reviewed on a monthly basis.

School sports and field trips are proceeding as normal and all other school activities are fully functioning.

Municipal elections for Mayor Council and School board trustees will take place on **October 18** and more information will be coming about advanced polls and voting locations.

September 30 has been declared as a National Day for Truth and Reconciliation with Aboriginal peoples and will be a school holiday.

We have added \$200,000 to the homeschool budget for this year.

- Daily screening checklist for staff, student and visitors
- Continuation of hand sanitization and cleaning practices
- Continue to practice physical distancing where possible
- Designated entrances and exits
- Volunteers and visitors are allowed in the school when prearranged and for specific purposes but limit the number of visitors (eg. Yearbook, hot lunch)
- Change in how we are cohorting compared to last year
 - Joint Recesses with special designated areas at recess
 - Classes are still cohorted however for instructional purposes we are permitted at times to un-cohort students (example – literacy intervention, some split class purposes)
- No more contact tracing
- o With respect to yesterday's announcement, at this time because we've already established many good practices with our masking, hygiene, general cohorting and physical distancing protocols the news yesterday will not change much of what we do.
 - As Superintendent Liguori's afternoon email today stated, we are still awaiting more specific directives from the ministry as they write the health order specific for schools. With that there may be more changes that we will be asked to accommodate. When and if that time comes, we will adjust, as necessary.
- o What happens when we are notified of a confirmed COVID-19 case
 - Confidentiality matters
 - AHS will not be notifying us and we are not required to notify EIPS
 - Persons who test positive for COVID-19 must isolate for minimum 10 days or until symptoms resolve (whichever is longer)
 - Proof of negative test is not required to return to school when isolation is completed
 - Quarantine of close contacts no longer required by AHS therefore whole classes will not be sent home unless specifically directed to do so by public health official
 - When a case is reported to the school we will provide general notification to affected staff, students and families so that they can monitor for symptoms and stay home if unwell.
 - Students/staff without symptoms come to school regardless of whether or not they are close contacts.
 - If our absentee rate is 10 percent or higher, AHS investigate and determines next steps. If an outbreak is declared, the province will recommend additional measures for us to follow.

As a result, on Sept. 23rd, Global News will be onsite filming on this project with one grade 6 class, and joining one kinder class on their forest walk. This is a very big honour to be chosen and part of this project.
 - o National Day for Truth and Reconciliation and Orange Shirt Day
 - Sept. 30 has been added as a school closure day. There were enough hours that an additional day will not be required except for adding June 28th for one Kinder class. Flags will be at half-mast, and at 9:30am there will be an online moment of remembrance across the district. More information will be shared with anything happening in the community on the 30th that families can participate in.
