Glen Allan School Council (GASC) Hybrid Meeting Thursday, February 20, 2025 Agenda & Meeting Minutes

Meeting called to order at 6:30 p.m.

- 2. Approval of January 16, 2025 meeting minutes (1 minute) *Council executive Motion to approve: Jenn Campbell; seconded by Rosa Bull*
- 3. School council updates (40 minutes)

Council Chair update Erin Barrett, on behalf of Erin Hamilton

- Playground RFP update

- Playground committee (Erin Hamilton, Grant Glowinski, Lana Lastiwka and Stacey Robinson) met with Strathcona County to review the six successful bids in the RFP.
- We were each asked to score the bids on the variety of play types (social, sensory, physical), variety of challenges for different types of abilities, the flow of play/ease of movement from one structure to the other, and the inclusion of community input/feedback into the design.
- The committee scores accounted for 75% of the total rating, with Strathcona County's score the other 25%. Their score included things like safety, materials used, company references, etc.
- Winning bid was selected last week!
- Since then, we were able to request a few modifications to the design, so will be sharing the updated design with everyone as soon as we have it. But to give you an idea, think brighter colours, accessible structures (and swings) and a pretty impressive new tower.

- Bylaws update

- Shared details via email with council, but in a nutshell we need to work on bylaws specific to the fund development committee, as what we have are council bylaws. (AGLC needs fundraising bylaws in order to issue a casino license)
- The entity registered with the corporate registry uses the name "Glen Allan School Advisory Council", but is actually the fundraising society. In drafting new bylaws, we may wish to consider making a name change, so that things are really clear. GASC is the advisory council and fundraising is completely separate, which should be named accordingly and match what is registered with the corporate registry.
- As such, we can not vote on amending the bylaws today as more work is required.
- The wait for Camrose casino is currently 40 months, which unfortunately means the school will not get a casino for a few years. This is not a result of our current delays, rather when we got bumped off the list in 2022. This was likely an honest mistake at that time, as the amended bylaws did not comply nor were they filed with the corporate registry (only posted on the school's website).

IMPORTANT NOTE: After connecting with ASCA, EIPS has learned that councils will receive one Zoom meeting link—however, there's a limit to the number of attendees on Zoom. As such, school councils are encouraged to sign on early and attend the events from the same location. For example, instead of having multiple members log into Zoom from their devices at home, councils should try to have members meet at one person's home, the school or another appropriate location to log into one device from there. There remains no limit on how many school council members can attend in this way.
