     Going forward Caitlin will be in the Fundraising portion of meeting
    - i. Yearbook update

Missing pictures from Christmas Showcase and Family Dance. Erin H. to send out a message from GASC email requesting photos from family. Lana noted that there are no photos from Remembrance Day as it was a solemn occasion, and shared that teachers have been reminded to add candid photos to the Google Drive. End of year events will include: Grade 6 grad, kinder grads, sports day, grade 5 DARE, spring sports, end of year field trips. Class photos should be on Edge website. One kinder portrait is missing, Lana said someone would be able to take it and send it.

Yearbooks will be printed for distribution in September. Lana said that Grade 6 books can be delivered to the Jr High school.

Caitlin to confirm payment schedule and invoices for yearbook.

## ii. Sports Day

June 6th in the morning - Sports Day - looking for volunteers . Partnered with Bev Facey - fitness class and sports medicine classes volunteers will come.

We had a discussion around Freezies for Sports Day and difficulties last year with freezing them in time. Agreed that Caitlin would purchase ASAP and start freezing. The budget for these is within the \$2500 allocated for back to school BBQ. 291 students total.

iii. Year-end staff appreciation

Plan is for gift cards again. Discussion to continue off line.

iv. Meet-the Teacher & playground opening

County can't guarantee that playground will be open for August 27 (Meet the Teacher). August 27th is the date of meet the teacher 5:00 p.m. - 6:00 p.m.

We decided to plan BBQ/Playground Opening for Meet the Teacher. Plan is to have one food truck ("Dawg Gone It" is top contender) and see how it goes, possible to plan another event in coming years with more food trucks. We will ask the County for access to the back of school so that the Food Truck can be next to the playground. Discussed having food truck 5:00 p.m. – 7:00 p.m. Each student would be given a \$5 coupon after they meet their teacher (coupon could be on their desk).

Plan to announce the event at the end of June so that families have it I mind.

We could/would supply drinks (Costco water?) - \$1600 for the hot dogs, leftover for water.

c. Insurance Update – *Erin Barrett* 

We discussed at this point in meeting because Insurance company was coming at 7:30

- i. Recommended by ASCA that fundraising association should have insurance:
- ii. General Liability protects in event of an accident -i.e. fall at at event, protects someone from suing members directly
- iii. Directors and Officers liability personally protects us and other volunteers
- iv. Also Crime Policy protect the association from theft or other crime
- v. Quotes provided by Cooperators, Alberta School Fundraising Association Insurance Program , and Westland Insurance. Please contact GASC for full quotes.
- vi. Nathan Ciezki from Cooperators came to the meeting to discuss insurance and present his quote. *Please see Appendix I for details*. Some key points shared/discussed:
  - Cyber Insurance: Nathan didn't think it was necessary because we don't have a website - google workspace, hot lunch, raffle box - it would cover a privacy breach. Cooperators to put together a quote for what this insurance could include.

- Crime: protect the association from theft or other crime
- Cooperators plan includes access to volunteers if needed (and available)
- Amended definition of employee: this makes it so that all volunteers and board members are considered 'employee' -Nathan advised - always ask about the definition of employee
- D&O financial loss as a result of a decision made by the committee - for the board member entity and the board members - excludes bodily damage
- To increase to \$2 million would need to build a business case based on members history etc. Underwriter would have to approve it. \$1 million is still okay for this small of a group
- Community Guard Program commits to if there is a
  premium increase, we guarantee that we won't increase
  more than a max of 5% per year if its over 5% they give you
  12 months to find a new insurance plan or will work with
  group to change the insurance plan. In the 12 months wait
  time, you keep the old premium.
  - a. Accessibility expertise in insurance for non-profits
  - Ongoing insurability risk management i.e. give advice if we are looking at big event and wants to reduce risk
  - c. Community Support can give a hand for community in need - can ask for a donation - Tom makes a donation, agency makes a donation or corporate.
     They also help as volunteers - they love to help out.
  - d. Cooperators is 100% Canadian owned and operators for over 80 years started in SK, expanded into ON, and now across Canada
- vii. We had a discussion around 'who is first payer' sounds like the bank pays first (if applicable), then school, then insurance.
- viii. Next steps: Nathan/Cooperators will provide a more up to date quote mid-August, with a plan to vote on insurance at September meeting.
- ix. Discussion after Nathan left: Should we have coverage before Meet the Teacher / BBQ / Food truck event? Generally agreed that we should have it set up before then. They will get us a quote for mid-August. Question should we have coverage before meet the teacher? Would need an ad hoc meeting.
- 4. Elk Island Public Schools (EIPS) Board of Trustees report Trina Boymook
  - a. The Board approved an increase to student transportation fees for the 2025/26 school year. Due to changes to the Student Transportation Regulation. 2025/26 will the final year for elementary students living between 1Km-1.59Km to be considered as eligible riders. The province is increasing the minimum to 1.6Km for elementary students while junior/senior high students remains at 2Km.

- b. The Board is set to approve a \$211M Budget at our May 29 Board meeting. This budget incorporates \$1.9M.
- 5. Principal/Assistant Principal's report Lana Lastiwka & Crystal Brownlee
  - a. Bell Schedule for 2025-26 To accommodate for the change in instructional minutes for early dismissal Wednesdays, our starts time will be 5 minutes earlier, 8:30 a.m., and dismissal will be 4 minutes later at 3:12 p.m. Early dismissal Wednesday's end time is 2:12 p.m.

    - Down 30 students from this year a large group of grade 6 students moving on, and a smaller number of kindergarten students registered
    - Classroom complexity one time allocation \$29 261
    - Classroom complexity funding \$296 560 used to support our inclusive classrooms - Mental Health Grant – in counsellor position - \$7894.00
  - c. Survey Responses
    - i. Areas of Success: Email is the preferred way of receiving communication BUZZ weekly; 100% of respondents agree their child is encouraged to do their best; 88% of respondents agree their child's individual needs are met; 92% of respondents agree their child is showing growth in numeracy; 94% of respondents agree that the school keeps them informed about their child's progress and achievement.
    - ii. Opportunities for Growth: 88% of respondents agree their child is showing growth in literacy; 81% of respondents agreed that their child has an understanding of First Nations, Métis and Inuit culture and history. (17% indicated they don't know, we include updates in the BUZZ, email our self-identified families a minimum of once a week). Any suggestions on how to communicate this are always welcome; 25% of respondents indicated that are dissatisfied or don't know about the resources available to support their child's learning (We will ask this question on the BUZZ, what resources?)
  - d. Mental Health Capacity Building Program 3-year program beginning September 2025.
    - i. Understanding the Brain
      - Insights into the nervous system's influence on our emotions, sensations, and behaviors.
      - Strategies to engage the prefrontal cortex for better emotional regulation and cognitive functions.
    - ii. Relationships
      - Development of relationship skills, social awareness and decision-

- making abilities.
- Focus on perspective taking, forming healthy relationships, teamwork, conflict resolution, empathy, values/identity and respect.

#### iii. Self-Awareness and Emotion

- Recognition and management of emotions, behaviors, values, strengths, and areas for growth.
- Practice self-regulation, gratitude, and mindfulness to build selfworth and resolve conflicts.

#### iv. Mental Health Literacy

- Understanding mental health and emotions, including recognizing different emotional states and their impact on well-being.
- Learning about the brain-body connection and developing strategies for mental health and stress management.


## 6. Teacher report – *Stacey Robinson*
